# Just to Summarize

#### Harassment

On June 3rd at 1:35am, Officer Todd Kintzi received domestic report from dispatch. The caller indicated he would like to handle the report over the phone. Officer Kintzi contacted the victim. The victim stated he was laying in bed when his girlfriend started harassing him while he was trying to rest. During the argument his girlfriend slapped and spit at the victim. The victim did not wanted to press charges or have girlfriend arrested. He stated his girlfriend was already on probation and he didn't want her to get into anymore trouble. To keep the peace Officer Kintzi suggested the victim stay somewhere else and advised him that he would be contacting Home Free and advising them of this incident.

### Neighbor Trouble

On June 5th at 11:09am Officer Nick Englund was dispatched to a neighbor trouble call. When Officer Englund arrived on scene he was met by reporting party. The reporting party stated she suspects the maintenance man threw dog scat on her front stoop, smearing it into the front door floor mat and aggressively flinging it upon the first floor window. Officer Englund did observe the scat and from his training and experience, it did appear fresh and recently relocated to the front stoop and ground level window. The reporting party did not witness the maintenance man smearing the scat but was told by an unidentified resident he did. Officer Englund did not observe any fingerprints on the scat so he suspected it was possibly placed with a gloved hand or by some other instrument such as a shovel. Officer Englund notified the building manager of the incident .

#### **Traffic Stop**

On June 3rd at 8:41am, Chief Shane Mikkelson stopped a vehicle for expired tabs. While on the stop Chief Mikkelson discovered the driver had put tabs on a license plate that belonged to another vehicle. Driver stated she purchased the vehicle 3 vears ago and it had never been registered because the dealership never sent her the title. The driver is working with the State of MN to get the vehicle registered.

## Medical/Unconscious

On June 8th at 6:23pm, Officer Anthony Mortinson was dispatched to report of an unconscious male that was barely breathing. When Officer Mortinson arrived he observed a group of people surrounding a male who was unconscious on the ground. A female in group stated that the victim was having a heart attack and needed to start CPR. Officer Mortinson advised her to begin compressions. At the same time a male in the group asked for the officers Automatic External defibrillator (A.E.D.). Officer Mortinson gave the A.E.D. to the requesting party. While the male witness prepared the unconscious male with the A.E.D. pads officer Mortinson prepared the oxygen and ambu bag to assist with CPR. When the A.E.D. was in place the male asked everyone to clear so he could deliver the shock. Once the shock was delivered the female immediately returned to compressions. Once the Hennepin County Emergency Squad arrived the female advised she needed to switch. During the switch the victim became conscious and breathing on his own.

#### **Civil Matter**

On June 4th at 6:11pm Officer Anthony Mortinson was dispatched to a civil issue. The reporting party stated she and her boyfriend got into an argument over who was going to wash the dishes. The reporting party wanted to leave with the cats but was denied by her boyfriend. Officer Mortinson stood by while the reporting party collected her belongings. Officer Mortinson advised the reporting party to handle property issues in a civil proceeding or through mediation. Bother parties were given victim rights information.

## **Animal Complaint**

On June 15th at 448pm Officer Brendan Current and Officer Todd Kintzi responded to a complaint of a man skinning a fox out side his garage. The officers made contact with the subject and inquired about his activities. The subject explained he noticed the animal, a red fox, dead on the side of the road on his way to work. He stated when his shift was over he picked the animal up and went home to skin the animal, keeping the hide. The officers explained that skinning an animal in a public place is not a good idea. The officers also stated he should call the MN DNR and inquire about registering the animal.

## Officer Assist

On June 28th at 6:35pm, Officer Jonathan Grimm and Officer Anthony Mortinson responded to a call of a 76 year old male who walked out of the memory care unit. Officers located the subject and assisted him back to his room.
