## Just to Summarize

### Open Door

On March 1st at 7:49 p.m., Officer Tony Mortinson was dispatched to a report of an open door. The reporting party found the front door of a home across the street open. The keys were still in the door, and the lights were on. A search at the home revealed no one inside and no signs of forced entry. Officer Mortinson contacted the owners of the home and learned the construction crew left the house open. Officer Mortinson secured the home and returned the keys to the owner.

### Hit-and-Run Accident

On March 4th at 11:03 p.m., Officer Heather Starry was dispatched to a hit-and-run at Duffy's Bar and Grill. The reporting party stated he witnessed a vehicle back into a wooden fence and leave. Officer Starry located the suspect with the license's plates that was provided by the reporting party. Charges are pending.

### Disturbance

On March 12th at 11:11 a.m., Officer Kintzi was dispatched to a verbal domestic call at the 300 block of 2nd St. SE. Dispatch advised an ex-boyfriend was refusing to leave. Upon arrival, Officer Kintzi met with the complainant who stated she wanted her ex-boyfriend removed from her home, so she could leave for work. The reporting party indicated her ex-boyfriend was not on the lease, and he is refusing to leave. Officer Kintzi spoke with the ex-boyfriend, and he decided to leave the residence voluntarily. Officer Kintzi mediated the incident, and no arrests were made.

### Disturbance

On March 31st at 11:30 p.m., Officer Todd Kintzi was dispatched to a civil dispute at the 300 block of 2nd St. SE. Upon arrival, Officer Kintzi met with the Reporting Party who stated her ex-boyfriend took her car and cell phone without permission. The reporting party did not want to press charges.

### Theft from Auto

On March 2nd at 4:37 p.m., Officer Todd Kintzi was dispatched to a theft from auto report at the 100 block of 5th Ave. NE. Upon arrival, Officer Kintzi met with the victim who stated his backpack was taken from his friend's car sometime over the weekend. The car was parked along the street, and the doors were not locked. The victim does not have any suspect information at this time. Investigation is pending.

### Suspicious Act

On March 5th at 1:05 a.m., Officer Greg Burstad was dispatched to a suspicious act report at the 600 block of North Oaks Dr. The reporting party stated an unknown female was walking around the parking lot carrying a bottle of liquor. Officer Burstad was unable to locate the subject. Officer Burstad tried to contact the reporting party but was unsuccessful.

### Suspicious Act

On March 26th at 3:22 a.m., Officer Todd Kintzi observed a vehicle located at the 300 block of Central Ave. with its windows and trunk open. Officer Kintzi located the owners and drove to their house. The owners stated he was unsure why the windows and trunk were open. The owner provided the Officer with the keys to the vehicle, so he could lock it up. The owner picked up the keys and car the next day.

### Theft

Upon arrival, Officer Kintzi met with the store owner who advised she was in the back room when she heard a loud bang come from the front of the store. She immediately went into the front of the store and saw a teen male jumping out of the open window. The reporting party found a broken picture frame laying outside the window. Officers checked the area but were unable to locate anyone matching the suspect description.

### Suspicious Act

On March 26th at 8:58 p.m., Officer Kintzi observed a motorcycle parked unattended in the lot of the Osseo Education Center. Given the time of night and rainy conditions, Officer Kintzi felt the motorcycle may have been stolen. Officer Kintzi approached the bike and noticed there was a temporary plate on the back from Osseo Power Sports. Officer Kintzi contacted the owners of the store and asked if they recently sold a new bike. The owner verified the sale. He also indicated the customer did not have anyone to drive his car home, so he parked the bike at the school until he could pick it up.
