Just to Summarize

Theft

On August 2nd at 11:29 A.M., Officer Michael Smith was dispatched to the 500 block of 5th Ave NE to a call of a theft from auto. Upon arrival, Officer Smith met with reporting party who stated his car was broken into. The reporting party stated he thinks his bank cards were left in the car. The reporting party stated he contacted the bank and learned that there were numerous fraudulent purchased on this debit card. The investigation is still pending.

Theft

On August 8th at 11:25 A.M., Officer Todd Kintzi met with the reporting party at the Osseo Police Department. The reporting party wanted to file a police report. The reporting party stated his garage was broken into and items were missing. The victim stated he last remember being in the garage on July 28th and doesn't remember if he locked the garage. There was no forced entry and the victim had no suspects at this time. The investigation is still pending.

Domestic

On August 9th at 5:27 P.M., Officer Todd Kintzi was dispatched to the 100 block of 6th St NW on a physical domestic between a father and son. Upon arrival, Officer Kintzi was approached by the reporting party who stated his son put him in a choke hold. The reporting party stated he kicked his son to get him to release him. Officer Kintzi located the suspect and arrested him for 5th degree domestic assault.

Shoplifter

On August 23rd at 2:00 P.M., Officer Todd Kintzi was dispatched to the 300 block of Central Ave to a shoplifter in custody. Upon arrival, Officer Kintzi met with the reporting party who stated the suspect attempted to pass all points of sale with a can of Lysol tucked under her armpit. A citation was issued for misdemeanor theft.

Overdose

On August 2nd at 1:57 P.M., Chief Shane Mikkelsen responded to the 600 block of North Oaks Drive for a drug overdose. Upon arrival, Chief Mikkelsen knocked on the door several times with no answer. Chief Mikkelsen noticed the door was unlocked so he enter and located the victim laying in the bed. Emergency personnel responded and transported the victim to a medical facility.

Assault

On August 5th at 11:50 P.M., Officers Peter Renteria and Tony Mortinson were dispatched to and assault at the 600 block of 2nd St NW. Upon arrival, officers met with the reporting party who stated he was outside when the suspect arrived and started yelling and becoming aggressive. The suspect then struck the reporting party in the ear and chest. Officers questioned the suspect and subsequently arrested her for 5th degree assault and transported her to the Hennepin County Adult Detention Center.

Suspicious Activity

On August 11th at 8:36 A.M., Officer Anthony Mortinson was dispatched to the 100 block of 1st ST NW for suspicious activity. Upon arrival, Officer Mortinson observed a male standing behind some delivery trucks. Officer Mortinson approached the subject and asked him why he was in Osseo. The subject stated he was homeless and walked to Osseo this evening. Officer Mortinson asked the subject if he would like to go to a shelter and the subject agreed. Officer Mortinson called around to the surrounding shelters and found one in Minneapolis that was willing to let the subject in. Officer Mortinson Transported the subject to Minneapolis.

Vandalism

On August 2nd at 3:07 P.M., Chief Shane Mikkelsen was dispatched to the 100 block of Central Ave on a vandalism report. Upon arrival, Chief Mikkelsen met with the reporting party who stated he came to work and found some cardboard signs taped to the front windows of his business. The signs were hand written and taped to the scripted lettering on the window. The tape from the signs ruined some of the lettering on the window. The reporting party estimated the damage to be around \$200.00. The investigation is still pending.

DWI

On August 6th at 1:27 A.M., Officer Brendan Current was assigned to a DWI enforcement detail when he observed a vehicle traveling northbound on Central Ave cross the centerline. Officer Current initiated a traffic stop and after a series of tests earned the driver was under the influence of alcohol. The driver was arrested for 4th degree DWI.

DWI

On August 21st at 02:07 A.M., Chief Mikkelsen was eastbound on 93rd at 6th Ave NE when he observed a vehicle swerve to the right and cross the center line. Chief Mikkelsen initiated a stop. Chief Mikkelsen approached the vehicle and observed the driver had glassy, watery and bloodshot eyes. After a series of tests, Chief Mikkelsen learned the driver was impaired and not able to drive. The driver was charged with 3rd degree DWI and released to his parents.
