# OSSEO ECONOMIC DEVELOPMENT AUTHORITY REGULAR MEETING MINUTES August 13, 2018

Grams explained the EDA members met today at 5:30 p.m. and visited the seven sites, spending approximately 10 minutes at each site. At the conclusion of the tour, the EDA members returned to City Hall to reconvene in the Council Chambers. He reported the plan is to review the sites and determine what the best course of action would be. He stated he would like to discuss this further with the EDA at its September meeting.

Hultstrom recommended Housing for All representatives attend the September EDA meeting.

Stelmach requested all types of housing developers be invited to the September meeting.

Johnson commented on the upcoming bus tour with Housing for All representatives.

Hultstrom discussed the Hickory Ridge affordable housing complex that was completed in Maple Grove and noted this was an award-winning development.

Johnson commented on a series of light rail redevelopment meetings he attended in Brooklyn Park.

City Planner Nancy Abts stated she was happy to be back at work fulltime.

Hultstrom explained she also attended the light rail redevelopment meetings in Brooklyn Park. She stated she enjoyed meeting with the developers at these meetings. She then discussed the Housing for All meeting she attended on July 24.
