- **Locations.** Summer 1 Monday programs meet at Sipe Park, 600 2nd Street SE, Osseo. All other programs meet at the Osseo Education Center, 324 6th Ave NE.
- **Priority.** Registrations will be accepted on a first-come, first-served basis, and programs may fill up. A waitlist is available. Registrants will be notified and fees refunded if their registration cannot be accommodated.
- **Dress code.** Participants should dress appropriately for the activity with close-toed shoes and comfortable, weather-appropriate clothing. Required sport-specific supplies will be provided. Tennis players are encouraged to bring their own rackets. Gloves are not required for T-ball/Baseball, but participants may bring them if desired.
- **Cancellations.** In the rare event of weather-related cancellations, notices will be emailed to parents/guardians who provide an email address. Notices will be announced on the City's website and social media accounts. One or two potential make-up days for weather-related cancellations are identified for the weeks following the regularly-scheduled classes.

- **Rates & Refunds.** Refunds and registration changes will be accepted up to 2 weeks (14 days) before the first day of the program. After this point, no registration changes or refund requests can be accommodated. Discounted "Resident" rates are subsidized by Youth Recreation funds in the city's budget. These rates are available on a first-come, first-served basis for Osseo, MN residents only, as long as funds are available.

Data Privacy Advisory

The following information about individuals who are enrolled in a City of Osseo Parks and Recreation program is classified private data: name, address, telephone number; other data that identify the individual; data that describe the individual's health or medical condition, family relationship, or living arrangements and opinions about the individual's emotional makeup or behavior.
3. The information you provide to the City of Osseo on the registration form is used to process your registration request and to determine staff, facilities and equipment needs, and to assist in notifying participants of scheduling changes.
4. Participation in any recreational program or activity is voluntary, and you are not legally required to provide the information requested on the registration form. However, if you fail to provide the information, you will not be allowed to participate in the activity or program.
5. Individuals or entities who are authorized to have access to your private information include: 1) City of Osseo staff who assist with recreation programs; 2) the City of Osseo's insurer and attorney; 3) coaches, supervisors, or instructors of the activity (who may be a City employee, contractor, or volunteer); 4) agencies that require access in connection with any legal claims; and, 5) other persons or entities as authorized by a court order.

LIABILITY WAIVER AND RELEASE

THIS LIABILITY WAIVER AND RELEASE ("Agreement") is dated as of today's date and is by and between PLA-IT, LLC (PLA-IT), Revolutionary Sports, LLC ("Revolutionary Sports"), and all other partners associated with this activity. Persons registering (and If such person is a minor, his/her parent or guardian), who along with the participant are collectively referred to as "User"). For purposes of this Agreement, "Management" means PLA-IT, Revolutionary Sports and any and all related entities, managers, governors, employees, independent contractors, coaches, instructors, agents, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of the premises or facilities used to conduct the event.

For consideration received, and in return for the use, today and on all future dates of the programs, activities, services, events, property and facilities provided by Management (the "Activities"), User and User's heirs, assigns and representatives hereby agree as follows:

1. User acknowledges there are inherent risks associated with participating in the Activities such as those described below, and hereby expressly assumes all risks, known and unknown, however caused and whether caused in whole or in part by the action, inaction or negligence of Management. Some of the inherent risks include, but are not limited to, injury, harm or death to User or persons around User, not only from User's own actions, inactions or negligence, but as a result of actions, inactions or negligence of others; the condition of the premises or any equipment used; certain hazards such as surface and subsurface conditions; collisions with other participants; the availability of emergency medical care; and the potential of other participants to act in a negligent manner.
2. User certifies that he/she has no medical condition that would cause participation in the Activities to be potentially hazardous to his or her health. If User is a minor, User's parent or guardian must be present at the Activity, or provide an emergency contact number for which such parent or guardian can be immediately reached in case of emergency. In case of injury or medical emergency and in the event User or User's parent or guardian cannot respond at the time of the emergency, Management has permission to seek, administer or have administered whatever first aid or emergency medical care deemed necessary for User's welfare, and it is understood that User, and not Management, shall be responsible for any and all charges for such health care services.
3. User assumes all risks in connection with the Activities, accepts personal responsibility for any damages following any injury, permanent disability or death and expressly waives any claims for any injury or loss arising therefrom. User assumes any and all risks involved in or arising out of User's use of any equipment or facilities relating to the Activities. User agrees to abide by and follow Management's rules and regulations which shall be provided and/or available from time to time.
4. USER EXPRESSLY RELEASES, WAIVES, DISCHARGES, AND COVENANTS NOT TO SUE MANAGEMENT FOR ANY AND ALL CLAIMS, DEMANDS OR DAMAGES RELATING TO ANY PROPERTY DAMAGE, INJURY, PERMANENT DISABILITY, DEATH OR OTHER DAMAGE OF ANY KIND, EVEN IF CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF MANAGEMENT OR OTHERWISE. USER AGREES TO HOLD HARMLESS, INDEMNIFY AND DEFEND MANAGEMENT AGAINST ANY AND ALL CLAIMS, DEMANDS, CAUSES OF ACTION, DAMAGES, JUDGMENTS, ORDERS, COSTS OR EXPENSES, INCLUDING ATTORNEY'S FEES, WHICH MAY IN ANY WAY ARISE FROM OR BE IN ANY WAY CONNECTED WITH USER'S PARTICIPATION IN THE ACTIVITIES OR USE OF OR PRESENCE UPON ANY PROPERTY OR FACILITY USED AS PART OF THE ACTIVITIES.
5. User further expressly agrees that this Agreement is intended to be as broad and inclusive as is permitted by the law of the State of Minnesota and that if any portion is held invalid, it is agreed that the balance shall continue in full legal force and effect. User waives the protection of any applicable statutes in this jurisdiction whose purpose, substance and/or effect is to provide that a general release shall not extend to claims, material or otherwise, which the person giving the release does not know or suspect to exist at the time of executing said release.
6. User grants Management permission to use his/her likeness in a photograph in any and all of its publications, including website entries, without any additional payment or other consideration. User understands and agrees that these materials will be the property of Management and will not be returned.
