### The 2020 Construction Season is Getting Underway!

The Osseo City Council awarded this project to Asphalt Surface Technologies on May 26th. Construction is anticipated to start around June 22nd and be completed by September. The project will reconstruct 2nd Avenue NE and 3rd Avenue NE between 4th St NE and County Rd 30 (93rd Avenue). Street reconstruction will include surface reclamation, reconstructing storm sewers, full replacement of curb and gutter, and the addition of sidewalk.

### Tree Removals and Replacement

Trees that are scheduled for removal will be marked with a pink ribbon in the coming weeks. Please check your property to make sure you are aware of any tree removals that will occur adjacent to your property. It is expected that tree removals could begin as early as June 22nd.

Trees that are removed as a part of the project are eligible for replacement according to the City's tree replacement policy. If you have a tree removed and choose to participate in the program, you can choose a replacement tree from a selection provided by the City. City staff will work with you to find a suitable planting location on your property.

### Sprinkler Systems & Invisible Fences

If you have a sprinkler system or an underground invisible pet fence on your property, please contact the project's Construction Observer. We will provide you with flags and can help you mark the locations of these items.

### Street Parking

On street parking during the working hours of 7am-7pm Monday-Friday and 8am-5pm Saturday will not be allowed within the project area. Vehicles that are usually parked on the street should be moved to other nearby streets that are not under construction. Vehicle access to driveways will be provided at the beginning and end of each working day. If driveway access is not available after working hours, you will be notified 24 hours in advance.

### COVID-19 Precautions

The Contractor will be taking extra steps to monitor and promote safe practices during construction. The construction staff will honor social distancing while interacting with residents and we ask that you do so in return. In order to achieve this we ask that you direct all in-person communications to the Construction Observer and avoid directly interacting with the construction crews, as much as possible.
