- The spouse, parent or stepparent, child or stepchild, sibling or stepsibling of any election judge serving in the precinct or of any candidate at that election (except relatives may serve on separate shifts from each other);
- Domiciled, either permanently or temporarily, with any candidate on the ballot at that election;
- A candidate in that election.
